ADMISSION PROCEDURES

■ The Bachelor's Degrees in French Law and Common Law or Spanish Law and the Double Degrees with partner universities are limited-capacity programmes.

The selection is made on the basis of the application file compiled via the Parcoursup platform. It will be supplemented by an interview, half in french, half in a foreign language.

■ Applications via the Parcoursup platform is required for:

· Holders or future holders of the French baccalaureate or an equivalent diploma from the European Union, the European Economic Area and the Swiss Confederation

· Nationals of an EU member state.
